#### **PROFILE**

Ummi Kalthum binti Shuib, has been working for more than 25 years in private and public services, in which 22 years of the tenure has been dedicated within the government's state and federal agencies. She has been responsible for creating and enabling communication between the government, stakeholders and especially the public at large. This was due to her responsibilty in managing the revenue center in Seberang Perai Municipal Council (MPSP) between 1998 to 2008. She had driven the changes and shifts of the management of MPSP's tax payers. Her creativity in simplifying many processes related to Assessment Tax has been benchmarked by other Local Authorities (LA) in Malaysia. Her achievement in MPSP includes the creation of new sources of income, re-establishing single servicing counters into multi servicing counters, redesigning the Revenue Collection System for MPSP such as by integrating bills and online payment gateways, two years advanced payment, debt collection and enforcement, also the central revenue reconciliation system.

The above initiatives has put MPSP in the world and country's maps in becoming the first LA to achieve and provide services and programmes such as, lucky draw for assessment's tax payers, SMS assessment's bill, online payment gateway, adverstisement on assessment's bill, electronic banking center, customer relationship management, public ratings and many other excellent small but impactful initiatives.

Due to her capabilities, KPKT has offered her to become the first Director of Finance at Solid Waste and Public Cleansing Management Corporation (SWCorp). She had already spent 13 years in her current position. She handles RM100 millions of operating funds and RM2 billion of Solid Waste and Public Cleansing Fund yearly.

As one of the pioneers in SWCorp, she had evolved in the formation of many policies, processes and systems in order to become the first Federal Agency in the world providing the solid waste and public cleansing services (PSPA). Taking over the services from 54 LAs in Peninsular of Malaysia, was such a challenge for SWCorp.

Her achievement in SWCorp includes the creation of the agency's overall coding system which is still in used, setting up of the asets, accounting and financial systems, PSPA Education fund, MOF's approvals to purchase a building as SWCorp's head quarter's in Cyberjaya and renovation of the building via financial loans. In ensuring the survival of SWCorp she had initiated a long term saving fund in order to repay back the building's loan, employees' medical expenses and cash award in lieu of leave (GCR). The fund was approved based on the 11 years of profits generated from her investment strategy which had amounted to RM104 million.

Apart of that, she is very much involved in public awareness about recyling, reuse and reduce (3R), #ValueFoodNoWaste campaign, 3R Bazar Online Shop, and also attribute her artistic skills in the creation of upcycling initiaves of Batik Pelangi.

With her passion in innovations and excellent track records of service improvement and incremental revenue generation, she will surely gives her best in any roles in order to lead, reform and drive changes in any organisation and Malaysia at large.
